# Resources and Ideas from SCA Prevention Networking Session 2/17/22

Outlined below are the updates, activities, ideas and resources shared.

#### Successes

- Held sober tailgate with two school districts in the fall. For one district the tailgate occurred before powderpuff football game. The game is held as a fundraiser, and the student council voted to have half of proceeds be donated to SCA. To give back the SCA is partnering with bowling alley to allow 4<sup>th</sup> and 5<sup>th</sup> grade students who completed Too Good for Drugs and their families to go bowling (includes food and prizes). Tailgate event included lawn games (e.g. corn hole) and "challenges" which included questions/trivia for that school district, questions specific to football and ATOD related questions (also included challenges/trivia for parents). Also gave out medication lock boxes, Deterra deactivation bags and Dispose Rx pouches. Along with the lock box, etc. was information for preparing for college visits. - Looking at how can establish focus groups and utilize graduate student intern to help improve media/messaging. Starting with messaging on gambling and older adults. Process of design and then sending through focus group will take more time but will be a good practice.
- County planning commission reached out to partner on safe medication disposal as they are concerned about protecting water supply/environment. New, non-traditional partner and they may purchase drug disposal bags.
- Using CBITS and Bounce Back. Have five groups up and running. Schools have been very supportive.
   Will be working with local child advocacy center to offer CBITS Families Plus to also work with the parents/guardians.
- Collaborating with Area Agency on Aging to offer training and support for kinship families (including families with grandparents raising grandchildren). Holding a two-day retreat for kinship families with workshops, panel discussion and other activities.

### Questions

- With increases in depression and mental health concerns considering adding a new priority risk factor to prevention plan. Have others considered something similar?
  - No one shared they had been considering, but some already had it as a priority risk factor.

- What have been experiences with vape detectors?
  - Cambria County school districts have shared positive feedback, have allowed them connect students to SAP and other services. Each purchased a different type and the quality of type purchased may impact how well detector works. Brands purchased include: VERKADA, FLYSENSE, ZEPTIVE, HALO.
  - Bradford County One district has found to be a nuisance because it goes off so frequently and lack staff capacity to follow-up when goes off.
  - There are detectors that can determine what is being vaped (e.g. marijuana, nicotine).
  - Bucks County Feedback from schools hasn't been very positive.
  - Lebanon County Schools like them (feedback has been positive). Do say they go off a lot, but have plan/protocols to manage.
- Has anyone had schools who took PAYS paper/pencil give their students an additional survey with the COVID impact questions that were only asked on online version of PAYS?
  - No one shared of schools who have done this or are considering it.
  - How are others doing with evaluation efforts?
    - o Consultants are a big help
    - SurveyMonkey has been a useful tool
