# Resources and Ideas from SCA Prevention Networking Session 2/27/2025

### Successes/Activities Planned/Resources

- Concerning Gambling Trends
  - Recently have been seeing youth gambling with cryptocurrency.
    - Upcoming webinar: Exploring the World of Crypto Assets, Gambling and Gaming
  - Cryptocurrency and pseudo day trading is an issue for college age young people (activities they are engaged in are essentially gambling)
- Planning a hybrid virtual and in-person FASD event/training. St, Luke's physician Dr. Meredith Birsner, a national leader in FASD, will present.
- Partnering with Villanova University to run responsible gambling ads during all their basketball games (ads on boards and in game PA announcements). Also including info about March Madness and responsible gambling into newsletter sent to students, alumni and anyone who has bought a ticket for a Villanova sports games.
- Launching a Saturday program for youth. Will provide Too Good for Violence and then do connected art activities (e.g. making vision board connected to goal setting). Had enthusiastic enrollment (20 kids enrolled in first two days).
- Too Good for Drugs Train the Trainer being sponsored by Clearfield-Jefferson Drug & Alcohol Commission on May 13<sup>th</sup> and 14<sup>th</sup> in DuBois. Contact Karen Orner by April 11<sup>th</sup> to register (korner@cjdac.org; 814-375-9002)
- Catch My Breath PE curriculum Implementing with teens in leadership in training programs. Includes many activities but try to follow the same themes/topics would in classroom.
- Have found success using incentives to encourage participation in programs (e.g. if complete program with 80% attendance, then can receive gift card). Have also found promoting programs on Facebook has worked well in some communities.

  - DDAP will be working to develop future problem gambling/gaming resources for different demographics/populations.
- How to address challenge of getting schools and parents interested in gambling prevention programming?
  - Frame programs around technology use and gaming. Parents are concerned about those topics. When just hear gambling think of things like casinos which they don't think are relevant to youth. Also incorporate gambling topics into programs/presentations framed as addressing stress and anxiety which are also topics of more interest to parents/schools.

- Connecting gambling prevention programs to ATOD and violence prevention programs. After do Too Good for Drugs or Violence, add two more lessons to address gambling, gaming and technology use. Has been most successful in 6<sup>th</sup> grade and up.
- When a parent/teacher night or other event brining in parents, provide parent workshops to cover topics such as how gambling shows up in gaming, prevalence of gambling, risks, etc.
- Has anyone done an awareness campaign on Adverse Childhood Experiences or Positive Childhood Experiences? Interested in learning from others on what was successful, lessons learned, etc.

- How to get parents to participate in programs (e.g. had presentation on current drug trends with only one attendee)?
  - Reframe the topic/name incorporate information into topics that parents are really concerned about and what to engage with.
  - Engaging key leaders to be messengers. Planning to go speak with local Rotary, Lions and Kiwanis clubs. Goal is that can present information to them as leaders in community who can then pass that information onto other parents.
- Does anyone know of any upcoming SFP 10-14 trainings? Fewer trainings being offered by Iowa State.
  - Potential federal funding cuts have led Iowa State to pause/limit training offerings so they can figure out impacts and plans.
- What has been other's experience with Too Good OST program?
  - Used to be after school activities kit, so OST is updated version. This version has more age categories (3) which has improved the program.
  - Experience with program has been positive. Has gone very well, great engagement.
  - Started Too Good summer camps. School counselors help recruit students who need extra support over summer.
  - Being used in settings such as after school programs, summer camps, community center, juvenile determine center, and summer learning programs.
